## FEES

1. The fee for the license required by Code Section 852.03 shall be one hundred twenty-five dollars (\$125) per week per licensee payable to the City of Greenville.  
A week shall be defined as seven consecutive days.
2. Licensee shall post a surety bond to the City in the amount not less than one thousand five hundred dollars (\$1500) with sufficient sureties, conditioned upon the licensee's faithful observance of the ordinances of the City. The Auditor shall determine if the proffered bond is valid, sufficient, and qualifying. Such bond shall have a stated duration set forth therein of not less than thirty days from and after the last day of the licensing period set forth in the license issued. If the potential licensee is one of several engaged by the same business: (1) If the licensee(s) are direct employees (Receive W-2's for tax purposes) the employer shall be required to post one bond for every ten (or part of ten) employees. (2) If the licensee(s) are independent contract employees (receive 1099's for tax purposes) the employer shall furnish an individual bond for each licensee.

REGULATIONS

1. Each licensee must conspicuously display a photo badge issued by the Auditor during solicitations.
2. Solicitations shall be restricted to the hours of ten o'clock (10:00) AM until seven o'clock (7:00) PM
3. At the discretion of the Auditor's office, the license may not be effective for up to twenty-four hours after time of issue.
